1. The Board heard a report from Associate Director Sharee Brewer regarding the regulatory activities from June 16, 2023 to August 10, 2023:

#### 1 Cases Closed:

**Case 2021.003** involved a complaint received from a business owner alleging a CPA had embezzled from him and his business during a time the CPA was personally involved with said business owner. Business owner made allegations after personal relationship dissolved. CPA was not indicted and Board staff received a signed court order in civil matter showing the civil case was dismissed. Matter was closed.

**Case 2023.006** involved a licensee who made a potential false statement on a renewal application where he attested to not having had any discipline against his license. Board staff learned from regularly reported means that another licensing Board had dealt with a CPE discrepancy the licensee had settled. Licensee attested his understanding that settling the matter wasn't discipline and had consequently answered the question in good faith. Renewal application question has since been re-worded to be more inclusive of any actions taken by other licensing Boards. Matter was closed.

Case 2023.008 involved a firm who received a fail rating on their peer review. Firm permit holder attested they had made a business decision to no longer perform work subject to peer review. Licensee cooperated with the peer review program and agreed to peer review committee requirement that if future audit work was undertaken at any time, the engagement would be subject to pre-issuance review. Case was closed with letter acknowledging the peer review committee's agreement and Board expectation of potential accelerated peer review as well. Matter was closed.

2. Ms. Brewer then discussed the open cases presented on the active case log.

# VII. Trial Board Hearing

After a motion and a second, the **Continuation Order 2022.113 was approved** by unanimous vote of the Board members present with Bill Kelly recused.
