The Board heard a report from Associate Director Sharee Brewer regarding the regulatory activities from January 26, 2019 to March 22, 2019:

## (1) Cases Closed:

**Case 2018.01** Case opened January 22, 2018 after firm received a peer review fail rating on preparation engagements. All requirements of peer review committee were documented to Board as met. Board approved an S&C agreement. Matter was closed.

**Case 2018.20** Case opened June 14, 2018, after receiving notice that firm had failed to schedule required peer review. Repeated attempts to get response from firm went unanswered until a Notice of Hearing and Complaint were sent to the firm. After that notice from the Board, firm was scheduled for peer review. Matter was closed.

**Case 2018.22** Case opened June 18, 2018 after determining firm had closed and 100% owner had retired without obtaining last peer review. Consent order was entered into and approved by Board to change license status from CPA-Retired to Revoked and fined \$1,250. Matter was closed.

**Case 2018.84** Cases opened September 14, 2018 after determining licensee had a CPE reporting deficiency of some sort. Notices of Hearing and Complaint were sent. Licensee contacted Board the week of previous trial board when license was subject to revocation and claimed to have been moving and not received notice. Licensee documented that CPE had been obtained during the reporting period. Licensee was fined \$250 on an S&C agreement. Matter was closed.

**Case 2018.128** Case opened September 5, 2018 for an out of state firm not responding to requests for peer review documents on a peer review that had a due date of November 30, 2017. Licensee provided documentation that firm was enrolled and had completed peer review under an extension by the out of state peer reviewer. Matter was closed.

**Case 2019.04** Case opened January 29, 2019 after receiving information of a case filed in Circuit Court by a former client alleging wrongdoing. Board staff learned the Licensee died January 11, 2019. Matter was closed.

## **VII. Regulatory Matters (continued)**

**Case 2019.08; 2019.09; 2019.10; and 2019.11** Cases opened January 29, 2019 after receiving complaint about four accounting firms showing in the Yellow Pages under the column titled "Certified." All accounting firms were contacted and asked to please request the Yellow Pages remove them from the column titled "Certified". All claimed to have not authorized this selection of placement in the Yellow Pages. Matters were closed.

**Case 2019.18 and 2019.19** Cases opened February 14, 2019 to address newspaper reporting of potential rule violation. Investigative Committee determined there was no rule violation and the matters were closed.

**Case 2019.20** Case opened February 22, 2019 after receiving no response from a Licensee randomly selected for CPE audit for 2017. Licensee responded providing all necessary documentation on obtaining CPE with no deficiencies. Matter was closed.

- 2. Ms. Brewer then discussed the open cases presented on the active cases log.
- 3. The Board heard the status/results of CPE audits for 2017 and 2018.
- 4. MSBPA project addressing out-of-state licensees working in Mississippi was discussed.
- 5. A letter from the Louisiana Board of Accountancy Director was discussed.
- 6. A request regarding peer review was reviewed and approved by the Board.

## **Consent Order:**

The Board approved a Consent Order in **Case 2019.16** involving a licensee found guilty of eleven (11) federal tax-related charges. Consent Order agreed to by Committee and licensee, and signed by attorney on behalf of licensee while case is under appeal. Order includes revocation of individual license and firm permit as well as civil penalty of \$8,750.00 and recovery of \$900.00 in administrative costs for a total of \$9,650.00. Additionally, the licensee will return the Certificate for the Practice of Certified Public Accounting to the Board.
