VII. Enforcement Matters (continued)

1) Cases Closed:

Cases 2022.112 involved a case that was recommended for closure by the legal counsel following discussion and advisement received in executive session on January 11, 2024. Matter was closed.

Case 2023.028 involved an individual licensee who requested an extension of time to obtain their CPE. Board granted the requested extensions and the licensee has complied with the extension by reporting and documenting their CPE to the Board. Matter was closed.

Cases 2023.146, 2023.147, 2023.148, 2023.149, and 2023.151 involved out of state firms who were disciplined by the PCAOB. Notifications of discipline were received from PCAOB and cases were opened to investigate. Staff were unable to determine any link existing between the actions of the out of state firms or subject engagements addressed by the PCAOB and the State of Mississippi. Matters were closed.

Cases 2023.154 involved an out of state firm who was disciplined by the PCAOB. Notification of discipline against the firm was received from PCAOB and a case was opened to investigate. Staff were unable to determine any link existing between the actions of the out of state firm or subject engagement addressed by the PCAOB and the State of Mississippi. In this case, the firm branch location addressed in the order was not licensed with this Board. Matter was closed.

Case 2023.156 involved an individual licensee on whom a complaint was received from a beneficiary of an estate. The answer to the inquiry received from the licensee was a letter and a follow-up phone call from the trustee of the estate stating emphatically the allegations were bogus and part of an ongoing dispute among the beneficiaries of the trust and had nothing to do with the professional services performed by the licensee. Matter was closed.

Case 2023.158 involved a case opened under similar circumstances to the matter heard in executive session on January 11, 2024. Per legal counsel and vote of the Board, staff are to address similar moving forward prospectively and not retroactively. Matter was closed.

2. An excerpt was presented from the Board's licensing system of the currently active cases.

VII. Trial Board Hearing
