(1) Cases Closed:

Case 2023.03 involved a CPA firm which performed a compilation but wasn't enrolled in peer review. Multiple attempts were made to reach the firm which went unanswered. Firm permit is now in closed status. This matter was re-opened under the active individual license to preserve jurisdiction. Matter was closed.

Case 2023.142 involved a CPA firm who received a fail rating on a peer review which included a review report. Firm was informed in writing if they stepped up to do audit work before receiving a pass rating on their peer review, the Board may consider requiring an accelerated peer review date or pre-issuance reviews. Matter was closed.

Case 2023.144 involved a CPA firm who resigned from peer review per ASCPA. Multiple attempts were made to reach the firm which went unanswered. Individual license and firm permit are both now in closed status. Note added to individual license and firm permit files in LARS that if either of them file for reinstatement, case will be re-opened. Matter was closed.

Case 2023.152 involved a CPA firm disciplined by the TBOA. Multiple attempts were made to reach the firm which went unanswered. Individual license and firm permit are both now in closed status. Note added to individual license and firm permit files in LARS that if either of them file for reinstatement, case will be re-opened. Matter was closed.

Cases 2023.157, 2024.02, and 2024.04 involved CPA firms who provided vague answers to the "discipline by other districts/boards" question as part of the firm permit renewal process for 2024. Responses received from all firms which better clarified the answers initially provided. Matters were closed.

Case 2023.159 involved a CPA firm which was censured by the PCAOB. Investigation was unable to determine a nexus to the public of the state of Mississippi either through the branch location in which the addressed activity occurred, the subject auditee, or other information made available in the PCAOB order. Matter was closed.

Case 2024.001 involved a CPA who was short on CPE reported to another state of licensure. Investigation determined licensee had all certificates reported to the MSBPA and was not short on what CPE was reported here. Matter was closed.
