### (1) Cases Closed:

**Case 2024.115** involved a licensed CPA firm holding two business licenses with the Secretary of State's office. Both business licenses reflected services meeting the definition of the practice of public accounting. Rules only allow a CPA to practice public accounting under the name of the firm permit issued by the Board. CPA firm closed the second business license and advised would only operate under the remaining one which carries the name of the firm permit issued by the Board. Matter was closed.

**Case 2024.116** involved a licensed CPA firm having a different business license name with the Secretary of State's office than the firm permit name issued by the Board. Firm permit name was amended with the Board. Matter was closed.

**Case 2024.126** involved a licensed CPA using their nickname on a review report issued to the State Board of Contractors. CPA was informed that firms may only practice public accounting under the name of the firm permit issued by the Board. Licensee advised in writing that it wouldn't happen again. Matter was closed.

**Case 2024.127** involved an unlicensed accountant reported as a CPA in an article in the newspaper. Accountant reported that he had not represented himself as a CPA but worked for a CPA firm and newspaper presumed such and misrepresented the situation without his or the firm's knowledge. Firm also acknowledged no role in the misrepresentation. Matter was closed.

2. An excerpt of the currently active cases was presented from the Board's licensing system.

## VII. Trial Board Hearing

There were no items for consideration.
